- Host a minimum of 3 meetings (in-person/virtual) throughout your area
  - o Provide notification to ALDOT Region Personnel to attend
  - Open House format
    - Provide a Sign-in Sheet
    - Materials such as STIP Brochure
      - Provide hard copies of materials or direct to the ALDOT webpage
- Advertise RPO meeting announcement as document in RPO's PIP
  - Particularly to underserved areas
- Provide ALDOT Bureau of Office Engineer/Planning Studies Section documentation of outreach efforts no later than July 2023 (TBA)
- Optional Public Outreach for RPOs:
  - Physical Public Display at local office
  - Assist ALDOT in Newspaper Advertisements for Open Comment Period (May-June 2023 dates TBD)
    - Run Legal Notice at least two weeks in major Newspapers within the Region Area
      - ALDOT OE/Planning Studies Section can provide along with a charge number (by request)
      - Must coordinate with ALDOT Regions
  - Use Social Media Accounts (if available)

## **ALDOT Region Personnel Outreach**

- Host at least two (2) open house meetings
  - May coordinate with RPO (if needed)
